Graphics should be inserted on the page where they are first mentioned (unless they are equations, which appear in the flow of the text) ([3]).

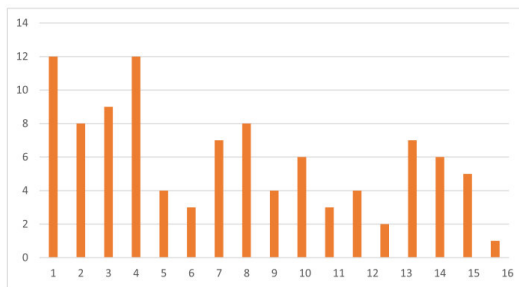


Fig. 1 An example figure caption.

3.2 Tables

Tables typeset in RSC house style do not include vertical lines. Table footnote symbols are lower-case italic letters and are typeset at the bottom of the table. Table captions do not end in a full point ([1], [3], [4]).
