CHAPTER 1

HOW TO USE THE TEMPLATE

1.1 Author Information

You need to provide some author information in the preamble. Example lines from `thesis.tex`:

\title{My Ground-breaking Research}

\degree{Doctor of Philosophy}

```

These information are needed to generate the preliminary pages.

1.2 Preliminary Pages

Once in the main document body, `\frontmatter` sets up the, well, front matter. This include setting the page numbers to lower-case Roman numerals.

`mmthesis` can generate the cover page, title page, copyright page and declaration page with the following lines (included in `thesis.tex`):

1.3 Acknowledgements and Dedication

These are provided using `\acknowledgements` and `\dedication`:

```

supervisor...}
\dedication{To my parents, my husband, and my daughter.}
```

1.4 Abstract

Write your abstract in a separate file (`sample-abstract.tex` in this example), and include it in `thesis.tex` like this:

\abstractfromfile{sample-abstract}
```

1.5 Table of contents, List of figures and tables

These are auto-generated by the following lines (included in `thesis.tex`):

1.6 Preface

Write your preface in a separate file (`sample-preface.tex` in this example), and include it in `thesis.tex` like this:

```
\prefacefromfile{sample-preface}
```

1.7 Main Chapters

I highly recommend that each chapter be written in a separate file. For example, `chap-intro.tex` has the contents

```

\chapter{Introduction}  
This is the introduction chapter.  
  
\section{Problem Background}  
We study the...
```

And chap-litreview.tex:

```
%!TEX ROOT=thesis.tex  
\chapter{Literature Review}

Researchers first attempted to...
```

In thesis.tex, these chapter files are included with the following lines:

```
\mainmatter           % signal start of main chapters  
\include{chap-intro}   % no .tex extension!  
\include{chap-litreview}  
\include{...}
```

The *%!TEX ROOT=thesis.tex* indicates to TeXworks (and also TeXshop on the Mac) that chap-xxx.tex are ‘sub-files’ of thesis.tex. This means if you hit **Ctrl** + **T** when you are editing chap-xxx.tex, thesis.tex will get compiled instead. Neat eh?

1.8 Appendices

Again, I recommend keeping each appendix chapter in its own file e.g. `app-uml-diagram.tex`:

And in `thesis.tex`:

1.9 Citations and Bibliography

`mmthesis` uses the `apacite` package to format citations and bibliography in the APA style. Note that `mmthesis` modifies the bibliography list by adding a numeric label to each entry, in line with MMU's requirements.

Here are some useful variants of the `\cite` command; see the `apacite` manual for full list.

- `\cite{Lim:2009}` → (Lim, 2009)
- `\citeNP{Lim:2009}` → Lim, 2009 (no parenthesis)
- `\cite<see>[p.~7]{Lim:2009}` → (see Lim, 2009, p. 7)
- `\citeauthor{Lim:2009}` → Lim
- `\citeyear{Lim:2009}` → (2009)

In `thesis.tex`, these lines will print the bibliography list:

1.10 Glossary

You can maintain a consistent glossary and acronym list using the `glossaries` package. It also supports acronym expansion on first mention!

First, define your acronyms and terms in a separate file e.g. `myacronyms.tex`:

Loading the glossary and acronym list, and later printing the list in thesis.tex:

To mention them in the text (i.e. chap-xxx.tex etc):

1.11 End Notes

MMU thesis guidelines seem to require end notes rather than footnotes. In any case, even if you prefer footnotes, use `\footnote`; if you prefer endnotes, use `\endnote`.

While foot/end notes are not encouraged in scientific and engineering disciplines, if you do have any, the following line in thesis.tex will list them out:

```
\theendnotes
```

1.12 Index

If you want to include an index for your thesis (it's optional), use `\index{keyword}` to insert index markers in your chap-xxx.tex or app-xxx.tex files. Then in your thesis.tex, after the Glossary and Notes:

1.13 Publication List

Make sure you have included your own publications in your .bib file. To list your publications at the end of your thesis.tex, with journal articles and conference proceedings categorised separately:
