Other useful tools are

- Detexify, which can convert your drawings to $\mathrm{LAT}_{\mathrm{E}} \mathrm{X}$ commands,
- Mathpix tools, which you can use to screenshot an equation and it will convert into $\mathrm{EAT}_{\mathrm{E}} \mathrm{X}$ equation form to be copied into your .tex document,
- Grammarly is a great help for grammar assistance on overleaf.

## Chapter 2

## Some helpful reminders

### 2.1 Citations and Reference

The common two ways of doing it is by numbers (generally Vancouver style [1, 2]) or by author-year (generally Harvard style [3, 4]). These citations are clickable and will bring you to a general guide on how to prepare your references in general and also in $\mathrm{E}_{\mathrm{E}} \mathrm{E}_{\mathrm{E}} \mathrm{X}$, prepared by the Imperial College London library.

If paraphrasing can be done, that would be much more recommended than a direct quote. However, if the message cannot be transmitted through paraphrasing, a limited amount of direct quoting can be done. Also, self-plagiarism is still considered plagiarism!

### 2.2 Typography

Typically, scientific writing should be in the passive voice. The use of active voice has been more and more accepted in scientific writing, however, it is generally better to be in a passive voice. The bold style is not recommended to be used for emphasis. Excessive (or any) use of bold in text is frowned upon. Emphasis is usually done using italics.

The open quotation mark (') is different to the close quotation mark ('). An easy way to avoid this issue is to use the command enquote, which needs the package csquotes.

By convention, italics should only be used for mathematical terms (e.g. $l$ for length, $m$ for mass), while units should be in normal style (e.g. m for metre, and kg for kilogram). When writing symbols, it is generally recommended to keep one symbol to represent one quantity, while using subscripts to specify the specific quantity it represents. For example, for the population of Dublin, $P_{D}$ is good while Population ${ }_{\text {Dublin }}$ or Pop $_{\text {Dublin }}$ are not recommended. Always explain any variables introduced in the report.

in the figure captions if you wish to shorten the figure details at the list of figures.

## Chapter 4

## Evaluation

### 4.0.1 Scientific Analysis

When working on analysis, making assumptions is good if insufficient information is provided. However, any assumptions made should be clearly stated and described, and if possible, elaborated such that the assumptions made are logical. This also makes the assumptions thought out and can be scrutinised and analysed. It gives the readers some understanding of potential errors and uncertainties that arise from any of the data presented in the report, such that if any replication of research was done, potential deviation from the presented data in the research can be easily determined.

When presenting your values, take note of the use of significant figures or decimal places. The main thing that is driving the accuracy of the data is the uncertainty or error of the reading. Generally, high accuracy (thus a large number of significant figures) data is unlikely, and the general rule is to have the same number of significant figures as the value of the lowest significant figures in the calculation. However, if a value has a known uncertainty, it can be written until that level of accuracy (e.g. a measuring tape has an accuracy of up to 1 mm , so any measurements of length can have up to 3 decimal points in $m$ ).

Besides, when presenting the observation of data, any interesting findings should be discussed and analysed. If no interesting data is found, it is fine to just state the findings are trivial or within expectation and move on. Any data that is presented in the report should be discussed. Any data that is not discussed should not be presented in the report. If there is weird data that is suspicious, it is fine to just say that the results obtained are not within expectations, and discuss the possible errors causing the unexpected results, or potentially discuss what can be improved to obtain better results.

If an unexplainable result is obtained, it is fine to include it in the report but give some potential future work that can be done to resolve the error or explore the new discovery. Scientific work is a process of learning, and it is fine to obtain results that cannot be clearly explained. It is better to acknowledge the lack of understanding than to brush it off.
